PROCEDURE FOR HANDLING ESTRAY'S

I. Notice of Estray:

Make every effort to find and contact the owner of the animal, and tell him/her where the animal is located. If no contact can be made with the owner, you are to fill out a NOTICE OF ESTRAY form and make sure it is filled out completely.

II. Notice of Impoundment of Estray:

Again, you are to fill out the form completely. If the complainant wants the animal removed from the property, you are to make arraignments to have the animal removed, and it is to be taken to the Bee County Auction Bam in Beeville, Texas.

If the complainant wants the animal kept on his/her property, leave it there.

****** Where it say" said Estray will be sold at public auction/Sheriff's sale at "mark out public auction unless otherwise told not to do so.

Forms I & II will be taken to the County Clerks Office were it will be filed stamped and put into the Estray book. A copy of Forms I & II will be posted at the Courthouse and a copy delivered to the IT Department for posting on County Website. The originals will be brought back and kept in the file.

III. Affidavit of Publication and Posting of Notice of Estray.

This form will be taken to the IT Department at the Courthouse. You are to fill out the form and have it notarized. Leave a copy of the publication form at the IT Department and bring back the original and place it in your file folder. The publication will run for fifteen (15) day period.

IV. Report of Sale

At the end of the fifteen-day period, the animal will be sold. The Administrative Secretary will ask for a Report of Sale form (form IV). You are to fill out the top portion. Provide The Administrative Secretary with copies of forms I, II, III and IV, she will send all forms to the Beeville Livestock Commission, in Beeville Texas.

V. Affidavit of Ownership of Estray

This form will be filled out when owner of the animal come and claims it. The following steps must be taker₁.

- 1. Owner must have proof of ownership
- 2. He will pay all costs and damages for the keeping of the animal
- 3. If he refuses to pay costs and damages, the animal will be sold.

All original forms will be turned over to the Estray Officer. This report will be kept in a file in the Sergeants Office. A number will be assigned to the Estray report. DO NOT USE AN OFFENSE NUMBER ISSUED BY DISPATCH. These reports are separate and completely different. Contact the Estray Officer for help with the forms.
